For the attention of Pharmacy, Optometry and Dentistry Services:

As you are aware the Integrated Care Board (ICB) is now the responsible commissioner of your service and as part of these arrangements, we want to ensure that all NHS dental practices, pharmacies and optometrists are aware of the safeguarding processes within the ICB and more generally across both Shropshire and Telford & Wrekin.

The ICB have designated professionals for both adult and children safeguarding, and Named GP's. It is part of our role to seek assurances that commissioned services staff and contractors working with the ICB know how to identify concerns and raise safeguarding referrals for either children or adults with the relevant local authority children and adults social care teams – PLEASE SEE INFORMATION BELOW.

There may also be occasions when you require advice and guidance or would like to arrange either children or adult safeguarding supervision to help you address some issues you are currently managing or have been involved in – in which case the ICB designated safeguarding professionals would be pleased to assist and our contact details are below. The ICB safeguarding team will also share information when there is good practice or learning. We will share this learning with you via our quality lead within the ICB and we would ask that the information is disseminated within your areas.

In addition, please could you also forward the self-assurance report which NHS England have previously sent to you all. It would be really beneficial for the ICB to have this information and evidence of the good work already underway and where applicable it will provide useful supporting evidence for you about CQC Regulation 13: Safeguarding service users from abuse and improper treatment.
